Do NOT leave your check and/or paperwork in the HLYC shop with the management company.

The member does hereby warrant and represent to HLYC that s/he now has and shall throughout the term of this agreement keep in full force and effect insurance on the boat and all equipment thereon, insuring the boat for loss from fire, theft, upset and other perils including fuel and spill liability coverage now or hereafter customarily included in all-risk marine insurance policies.

The member agrees to release, indemnify, and hold harmless, HLYC, of and from any and all claims for damage, loss, expense, and cost, of any nature, arising by reason of use of the rack storage, club services, adjacent docks, pilings, piers, and all other property of HLYC. This agreement shall be construed under the laws of the State of New Hampshire. If any provision of this agreement, or portion thereof, or the application thereof to any person or circumstances shall, to any extent, be invalid or unenforceable, the remainder of this agreement shall not be affected thereby and each provision of this agreement shall be valid and enforceable to the fullest extent permitted by law.

Boat Storage: Boats are stored in permanent racks at all four levels in the building, on moveable racks and trailers in the center floor, or directly on the floor (e.g., pontoon boats). Dripping water, oil, grease, etc., does occur and may cause soiling to other boats and their accessories while in storage. On occasion, wildlife may enter the boat storage building including birds, squirrels, chipmunks, raccoons, mice, etc. Members are reminded not to leave items aboard that may attract animal life. Neither HLYC nor the Management Company shall be responsible for such problems or conditions.

Once in - Once out: Extra winter storage provides members with exactly once-in once-out service either by forklift or trailer.

Boat Attachments: Neither HLYC nor the Management Company is responsible for damage to anything that is under or attached to a boat which might be damaged by the forklift: speedometer sensors, transducers, trim tabs, swim platforms, boarding ladders, etc. If you have any question about items on your boat that may be vulnerable, please ask the Management Company. By its nature, moving boats by forklift may result in cosmetic damage to fiberglass or gel coat surfaces. Neither HLYC nor the Management Company shall be responsible for such problems or conditions.

Dates: Extra winter storage begins no earlier than October 16 and ends no later than May 15. At season closing, possibly as late as November 20, boats are loaded into the building as permitted. At season opening, possibly as early as April 1, all movable racks and boats from the center floor of the building are moved to the outside parking area. Please stay in close contact with the Management Company to arrange for a timely drop off in fall or pickup in spring if you are concerned about your boat being left outside. The owner accepts responsible for any weather-related damage while the boat is outside before closing and/or after opening. A \$20/day late fee may be assessed for boats not picked up by May 16.

THE UNDERSIGNED MEMBER REPRESENTS THAT S/HE OR AN IMMEDIATE FAMILY MEMBER IS THE BOAT OWNER, AND HAS READ AND ACCEPTS ALL CONDITIONS IN THIS DOCUMENT.
